**NOTICE TO CALIFORNIA DEALERS ONLY**

# MSRP HANGTAGS REQUIRED ON ALL NEW MOTORCYCLES FOR SALE

As a courtesy reminder, no licensed motorcycle dealer in the State of California may sell, offer for sale, or display any new, assembled motorcycle on its premises unless there is securely attached to its handlebar a label (“MSRP Hangtag”) that includes, among other things, the manufacturer’s suggested retail price (“MSRP”) of the motorcycle as indicated by the manufacturer in compliance with both California Vehicle Code § 11712.5 and § 24014<sup>1</sup>. The **dealer** must then add to the MSRP Hangtag any amount charged **by the dealer** over and above the MSRP for (1) transportation to the dealership; (2) assembly, preparation, or both of the motorcycle; and (3) each dealer added accessory or item of optional equipment (collectively, the “Dealer-Added Costs”).

MSRP Hangtags are available to you from Suzuki Motor of America, Inc. (“SMAI”) for current 2017 model year as well as 2016 model year Suzuki-brand motorcycles and scooters at [http://adplanner.suzukicycles.com/product\\_hangtags.aspx](http://adplanner.suzukicycles.com/product_hangtags.aspx).

**Please ensure that every new Suzuki motorcycle or scooter sold, offered for sale, or displayed at your dealership has a MSRP Hangtag affixed to the handlebar as required by California law<sup>2</sup>.**

Please be aware that it is **your** responsibility to complete the Dealer-Added Costs and the total of the MSRP plus Dealer-Added Costs to get the total recommended retail price on the MSRP Hangtag in accordance with the California Vehicle Code.

You should consult with your own lawyer should you require further information about compliance with California law.

## **MSRP HANGTAGS REQUIRED ON ALL NEW MOTORCYCLES FOR SALE**

### **California Vehicle Code § 11712.5:**

It is unlawful and a violation of this code for a dealer issued a license pursuant to this article to sell, offer for sale, or display anynew vehicle, as follows:

- (a) Anew motorcycle unless there is securely attached thereto a statement as required bySection 24014.
- (b) A new light duty truck with a manufacturer's gross vehicle weight rating of 8,500 pounds or less unless there is affixed to the light duty truck the label required by Section 24013.5.

### **California Vehicle Code § 24014:**

(a) No dealer shall sell, offer for sale, or display, any new, assembled motorcycle on its premises, unless there is securely attached to its handlebar a label, approved by the Department of Motor Vehicles, furnished by the manufacturer, on which the manufacturer shall clearly indicate the following:

- (1) The recommended retail price of the motorcycle.
- (2) The recommended price for each accessory or item of optional equipment physically attached to the motorcycle at the time of its delivery to the dealer.

(b) The dealer shall clearly indicate on the label, furnished by the manufacturer, the following:

- (1) The amount charged, if any, over and above the suggested retail price for transportation to the dealership.
- (2) The amount charged, if any, for the assembly, preparation, or both, of the motorcycle.
- (3) The amount charged, if any, for each dealer added accessory or item of optional equipment.
- (4) The total recommended retail price of the vehicle which shall be the aggregate value of paragraphs (1) and (2) of subdivision (a) and paragraphs (1), (2) and (3) of subdivision (b).
